Erratum

Three minor errors that escaped the authors' attention at the proof stage of this study are corrected below.

(1) On page 16, under distribution of *Alpheus agilis*, it is stated that the species is found only in the eastern Atlantic (São Tomé and Cape Verde). However, additional material of *A. agilis* (Anker *et al.* 2009: p. 12) also includes specimens from Brazil, which is also obvious in the discussion (p. 12) and in Fig. 6, with two terminals of *A. agilis* WA-Br (Br for Brazil). The amphi-Atlantic distribution of *A. agilis* is also correctly pointed out in the abstract. Therefore, the error remains only in the distribution section of *A. agilis* on page 16, which should read:

Distribution. Eastern Atlantic: São Tomé and Cape Verde. Western Atlantic: Atol das Rocas (Brazil).

(2) In the acknowledgements on page 19, the official country name of São Tomé and Príncipe is Democratic Republic of São Tomé and Príncipe (instead of "Democratic Republic of São Tomé"). The same error also occurs in Anker *et al.* (2008a, 2008b, 2008c) and should be corrected there as well.

(3) The Portuguese name of the Brazilian archipelago of Fernando de Noronha is mis-spelled as "Fernando do Noronha" on pages 2, 6, and 21 in Anker *et al.* (2009), and also in Anker (2007), Anker *et al.* (2008b, 2008c, 2008d), and Anker (2012); read Fernando de Noronha in all these studies.
